18 mills non-homestead property tax renewal

This millage will **NOT** increase property taxes for homeowners. It is assessed only against business, industrial, commercial, rental, and some agricultural properties. This millage will allow the District to continue to levy 18 mills against non-homestead properties.

The non-homestead millage rate is necessary for the District to receive the state revenue per pupil foundation guarantee. Essentially, the millage renewal will also ensure that the District receives the state's full funding allotment under Proposal A.



Your vote will help determine the future of the nearly 3,000 students who attend Marysville Public Schools every day.

18 mills non-homestead renewal

Q&A

Q: *If I vote "yes," will property taxes on my home increase?*

A: **NO.** This is a renewal of the previously voted operational millage that is levied only against business, industrial, commercial, rental, and some agricultural properties.

Q: *Why is Marysville seeking this millage?*

A: Approval would maintain the voter approved tax rate of 18 mills on non-homestead property. If this election is not successful, Marysville Public Schools will lose over \$3 million of annual school funding for the 2016-17 school year.

Q: *Is Marysville the only district asking for a renewal of 18 mills?*

A: By law, voters in **ALL** Michigan public school districts have to vote on the non-homestead millage. Marysville's levy of 18 mills expires June 30, 2016.
